Project News & Events



Moravian Silesian Region

On September 11th, Moravian-Silesian region realized one Import workshop, where the experts from the Netherlands, Sweden and United Kingdom had attended to import their good practices and to draft Regional Action Plan. During the import workshop were discussed issues about area Park&Ride, Cycling, Sustainable urban mobility plan, Electric vehicles charging network.



Kronoberg

Kronoberg has organised 2 Import workshops. The first one was organised on 24th April, for internal people in County Administrative Board, and the second on 30th of May, for companies and organizations from whole Kronoberg region. The aim of the workshops was to receive feedback on first draft of our environmental action plan that will add to RAP.

RESOLVE Import Workshops started!



In Semester 5 the RESOLVE Import Workshops have started. After hosting the Peer Reviews and attending a number of Study Visits, the partners are now entering the final phase of their "learning curve" in RESOLVE. This will be done by the Import Workshops. These are meant to help partners to deeply exchange views on the Good Practices they would like to introduce together with their Local Stakeholders Group. Additionally, during the Import Workshop the first draft of the Regional Action Plan can be discussed.

The first Import Workshop took place in Maribor (P5) in May 2018. Experts from the Erasmus University Rotterdam (P2) joined policy makers and other local stakeholders in Maribor to talk about the plans the city has to improve the attractiveness of the city centre and, at the same time, to stimulate sustainable mobility among the visitors.

Kronoberg (P6) has organised two Import Workshops: the first (in April 2018) was meant for policymakers within the County Administrative Board and the second (in May 2018) for companies and organizations from whole Kronoberg area. The aim of the workshops was to receive feedback on first draft of the environmental action plan that will add to RAP. In total, approximately 50 people attended the two workshops. "By having a good dialogue with local stakeholders, we believe that our policy will improve more efficiently" said Aida Ramic, project manager for Resolve in Kronoberg. "When the right people are involved in decision making process at earlier stage, the results are clearer and more specific. We have also involved the management level of stakeholders group and hope that improves will be made quicker".


RESOLVE good practices

Greater Manchester





In order to develop a SUMP that was relevant to the City Region area, Transport for Greater Manchester (TfGM) compiled evidence bases on a range of factors. TfGM compiled six evidence bases to support the development of the Greater Manchester SUMP and ensure the intentions and aspirations featured within it were grounded in trends and data that were locally relevant. The 6 evidence bases were:

- Economy and employment
- Society and community
- Urban development
- Environment and resources
- Technology and innovation
- Policy and governance

SUMP Spatial Approach

By developing a SUMP with a spatial approach it has enabled the GM city region to maintain regional, strategic and multi-modal oversight in transport planning and service delivery, enabling cross-sector integration, particularly with landuse planning.

This is the first time a SUMP has been produced that considers transport spatially and holistically. Prior to this, transport investment had been planned and delivered as per the requirements of individual modes and needs of individual districts. As a result of this approach, our SUMP is structured around Network Principles and Spatial Themes rather than by individual modes.


